President's Foreword



Dear Friends of CSA,

It gives me great pleasure to share with you the achievements of the last year and our plans going forward.

Last year was a watershed year for us in many ways. The new CSR policy that obliges corporates to spend on social objectives has come into force and FY14-15 was the first year of its implementation. We were selected as the CSR partner by Accelya Kale and received very significant financial support from them. We also have been empanelled with two other corporates for their CSR initiatives.

This financial support enabled us to scale-up our programs significantly. During FY 14-15, our spending crossed the Rs 200 lakh mark, a big milestone in our history. This is reflected in our work – we added 13 child care institutions (CCI's) and nearly 800 children to our programs. This means that our programs reach 59 orphanages and adoption agencies and benefit 2800+ children across 4 states in the country.

During the year, one of our major initiatives was the WaSH – Water, Sanitation and Hygiene Program. Here we undertook a comprehensive up gradation of facilities at the CCI's that we support – a total of 47 bathrooms and 37 toilets were built, water purifiers were supplied to 22 institutions and large scale up gradation (painting, drainage and kitchen renovation etc) was done to create better living conditions for 1850+ children. The infrastructure work was supported by training on hygiene habits and provision of personal hygiene kits to nearly 3000 children. Along with our Health and Nutrition programs, our goal is to ensure that the basics of wholesome food and healthy environment are a given to all the children under our CCI Support Programs.

At the same time, we recognise that WaSH, Health and Nutrition are only the foundation stone to child care. The goal of holistic rehabilitation can only be met by better educational outcomes and better opportunities for vocational training and higher education. Also it is very important that the handholding extends beyond the age of 18 and helps children get jobs and proper livelihood and prepare them living independently. Only then can we say that we have truly transformed a life in a sustainable way. Huge gaps exist in these areas – we have started some pilot programs and will continue to focus in these areas in the years to come.

On the Adoption front, we received close to 1500 queries at our Helpline from prospective AParents. We directly facilitated 38 adoptions. However the most satisfying achievement was the transfer of 6 children from orphanages to adoption agencies and from there to loving families! This is very satisfying, there is no substitute to a loving family and no greater satisfaction for us then to make a life altering and permanent difference to children. This experience is also an interesting pilot – it shows that there are children in orphanages who can and should be a family – adoption numbers can be increased. In coming year, we will take this work further.

We have prepared our 3 year Plan. Our goals are: 1) To scale our Go Wide and Go Deep Programs for CCI's to reach 6000 children 2) to improve the effectiveness and efficiency of our Programs by leveraging technology and partnerships and 3) to build a strong corpus and resource mobilisation capability for the organisation.

On behalf of all of us at CSA, I would like to thank you for your faith and confidence in us and support for the Cause. We can and must make a huge positive difference to the lives of these children who have come to CCI's seeking care and protection. We owe it to them and ourselves as well!

CSA – Our Genesis


Catalysts for Social Action's (CSA) journey began in September 2002, as a Not-For-Profit organization dedicated to the cause of child welfare and rehabilitation for children living in orphanages.

As part of optimal child rehabilitation, CSA facilitates Adoptions in the country; we work with existing adoption agencies in rural areas to facilitate the quality, speed and number of adoptions in India. We have successfully facilitated over **230+ adoptions** in India, so far. We believe that Adoption is the best form of child rehabilitation and our intention is to ensure that every adoptable child should find a home.

For many children, adoption is not possible and they grow up in a Child Care Institution. We believe that every such child should have a healthy and wholesome environment and be supported all the way till they become confident and independent individuals. With this objective, we support a number of child care institutions in the areas of Infrastructure support, Health & Hygiene, Nutrition, Education and Vocational skills activities. CSA not only cares but also goes beyond, thus, enabling children to be self-sufficient and become contributing members of society.

We have **made a valuable difference to 2800+** children across **55+** child care institutions in **4** states that we support.

Our BIG Story – Raising Standards of Childcare – Juvenile Justice Act Audit

CSA employs a two pronged approach to childcare in child care institutions / orphanages –

1) We conduct **need based analysis of child care institutions and work to improve and enhance the quality of care to children** in selected orphanages in the areas of health, hygiene, nutrition, education, infrastructure support, vocational training etc. The objective is to make a difference to the lives of these children so that they can grow into contributing members of our society.

2) **Work with the founders, trustees, management and staff of child care institutions in 'Raising Standards of Childcare' through enhancement of processes related to their governance, finances & day to day management.**

An up gradation of existing facilities, child care conditions and organizational capability (registration, access to funding support, childcare and caregivers training etc). This is done in a sustainable manner, so that they can look after children in a better environment going forward.

Therefore, the overarching goal is to support Children and Child Care Institutions in becoming self-reliant.

An evaluation of the overall functioning and effectiveness of a CCI on a given number of parameters as per the JJ Act 2000 is audited by a tool – **The JJ Act Audit**. This tool was developed by Aangan India in association with UNICEF. This is an effective tool in evaluating several standards of care at CCIs. Various criteria basis which CCI evaluation is done are as follows –

- Management & Staffing
- Physical Facilities & Safety
- Protection & Safeguarding
- Health & Sanitation
- Nutrition
- Education & Recreation
- Psychosocial Care
- Life Skills & Vocational Training & Placement
- Case Management
- Exit Preparation & Follow Up

Each criteria is drilled down further and then a score per criteria is arrived upon which then totals to an overall score.

CSA staff have been trained to make use of the JJ audit in evaluating the CCIs we work with. CCIs recording lowest scores on given parameters are identified as areas for improvement – 'RED' flag areas & these areas can be worked upon to improve overall standards of child care & protection being provided at the CCI.

We undertook this exercise in May 2014 and subsequently in Feb 2015 (after 8 months). We now have a comparison of scores & improvement percentage.

Overall **21%** improvement recorded across 43 orphanages / children's homes. The aim is to keep seeing an improvement in the scores which in turn would mean better Standards of Care and Protection for children residing in these children's homes.

- ✓ No. of CCIs assessed: **43**
- ✓ Improvement percentage across States: Goa – **17%**
Madhya | Pradesh – **33%** | Maharashtra – **14%**
Odisha – **18%**
- ✓ CCI showing MOST improvement: **JASODA ANATH ASHRAM in Odisha – 433%**
- ✓ At Jasoda Anath Ashram, CSA worked together with the management, trustees and staff of Jasoda Anath Ashram to address 'red' flag issues and an intensive childcare support was provided in the areas of Health (Checkups & Treatments), Hygiene & Nutrition (Hygiene kits, First Aid kits, Sensitization & Awareness trainings, introduced additional meal - Breakfast along with Milk), Education (Tutor provided, Caseworker appointed to look after children and other day to day activities), Infrastructure (6 toilets & 3 bathrooms constructed, water supply & drainage/septic tanks, electrical wiring & paintwork also undertaken), Children's Committee (Formation, Monitoring & Execution of suggestions made by children), CCI Capacity Building (appointed Caseworker to maintain documents and child files systematically, helped streamline internal finance & books of accounts, capacity building programs organised for staff of this CCI). We have received positive feedback from different stakeholders and it is heartening to note that several initiatives and changes brought about at this CCI have been appreciated.
- ✓ State showing MOST improvement: **Madhya Pradesh – 33%**
- ✓ This improvement in Madhya Pradesh is attributed to the intensive support being provided to 16 CCIs under **Project ASHA** which is supported by **ICICI Prudential Life Insurance Company Ltd.**

Our Imprint

CSA is committed to providing support to children in CCl's / Orphanages and AAs / Adoption Agencies with an aim to improve their overall living conditions. Our child care focus revolves around areas such as Child Protection, Health & Hygiene, Nutrition, Education, Vocational/Livelihood Skills, Exit Preparation, Recreation, Infrastructure support & Capacity Building of Childcare Institutions. These programmes are structured projects to achieve direct and measurable benefits for the CCl's and children under their care. We conduct need based analysis of child care institutions and work to improve and enhance the quality of care to children in selected orphanages. The objective is to make a difference to the lives of these children so that they can grow into contributing members of our society.

Here is an overview of the support provided and work that has been accomplished this past year.



Adoption Facilitation

- CSA facilitated **33** adoptions between April 2014 and March 2015
- CSA has been supporting the Love Trust Special Needs home in Buldhana district of Maharashtra for differently abled children since 2009. 3 children from this Home have now been adopted into loving families outside India – Nehal (4 yrs) is in the US, Niyati (5 yrs) in Germany and Bhavin (2¹/₂ yrs) has moved to Spain. Indeed, heartwarming adoptions and we wish these little angels a bright future with their families!
- The first case of **'Foster Parenting'** in Goa under Foster care scheme - Vatsalya has been facilitated by CSA in 2014. A 12 year old girl has moved in with her foster mother, indeed new beginnings for both mother & daughter!
- **Transfer of children** from orphanages to Adoption agencies – A child can be placed in adoption only by authorized AAs. A child who is in an orphanage, though adoptable, can never be adopted unless transfer takes place. CSA was instrumental in moving 6 children with the help of CWCs into adoption agencies and all of them have been adopted



Support to Children in Childcare Institutions

Wash (Water, Sanitation and Hygiene)

- Basic sanitation and hygiene facilities at CCl's are inadequate in most cases. This past year, we undertook a major project of constructing toilets and bathrooms & renovation, provision of safe drinking water, sanitation kits (disinfectant floor cleaners – Harpic, Lizol etc.), undertake other infrastructure work such as septic tanks, drainage, painting and electrical work, provision of water purifiers etc. A major part of this project was supported by **Accelya Kale Solutions Ltd.**



- Hygiene Kits are distributed to children twice a year – comprising of tooth paste, tooth brush, bathing soap, washing soap, sanitary napkins for older girls
- Hygiene Awareness sessions are conducted periodically on:
 - Personal hygiene
 - Dental care
 - Skin care
 - Importance of hand washing etc.
 - First Aid (for older children and CCI staff)
- In addition, we introduced awareness workshops on ‘Safe and Unsafe Touch’ for all children in the age group of 6-14 years of age. Aim of sessions was to:
 - Inform children about the various forms of safe and unsafe touch
 - Give children necessary information to prevent abuse
 - What should children do in case they are faced with such situations of potential abuse

The workshop consisted of a presentation and screening of video ‘Komal’ (Childline India), a brilliantly conceived short film on child sexual abuse

Impact

- Toilets & Bathrooms constructed – **89** benefitting **2375+** children
- Water Purifier – **22** CCIs & Adoption Agencies benefitting **800+** children
- Sanitation Kits – **70 kits** provided
- Building dormitories, painting, seepage prevention, electrical work, kitchen renovation, drainage system, playground, library etc. benefitting **1850+** children
- Hygiene Kits distributed – **2700+** (twice a year)
- Awareness sessions conducted – **2700+** children attended

Health & Nutrition

- Regular health checkups were conducted twice last financial year – physical examination, dental, eye and ENT done. BMI (Body Mass Index) was determined by measuring the height and weight of each child
- De-worming tablets for older children and syrup for younger children was administered during the health check sessions – aim is to ensure better digestion
- Children in need of extensive treatment post health checks were provided with required treatments
- Supplementary nutrition is being provided to children – fruits, milk, pulses, soya etc. OR a ‘fourth’ meal is being provided – either breakfast or evening snack – poha, upma, sattu, ladoos of groundnut & jaggery



Impact

- Health Checkups & Deworming – **2700+** children underwent checkups **2** times
- Children treated for various ailments – **1000+**
- Supplementary nutrition provided to **30+** CCIs & AAs – **1000+** children covered



Education

- In the past year, we have given form and shape to our Education module so as to develop a robust model that can be implemented uniformly across CCIs with the aim of providing good, quality education to children residing at CCIs
- Basic education related support is provided on an ongoing basis – school fees, uniforms, shoes, books, bags and stationery
- Appointment & Training of Tuition Teachers at CCIs to provide academic support and personal attention to children
- Develop and conduct Life Skill sessions for children above the age of 14 years at CCIs in areas such as Critical Thinking, Self-Awareness, Communication & Collaboration, and Teamwork etc.
- Conduct Pre and Post assessments for Language, Maths and Life skills to assess improvements made through the year



Impact

- Basic Education support – **1300+** children benefitted
- **23** Teachers appointed – **550+** children benefitting
- Teachers trained – **25** across MP and Maharashtra
- Life Skills sessions done – **72** hours benefitting **190+** adolescent children



Vocation & Exit Preparation

- In line with the Juvenile Justice Act 2000, a 'Child Care Plan' (CCP) is to be prepared for every child residing at a CCI – understanding the child's history, education level, strengths and weaknesses etc. CCP is prepared by involving the trustee, caretakers and the child
- Different Vocational training courses have been conducted across the board for children in tailoring, beautician course, two wheeler course etc. We have tied up with institutions such as Kohinoor Technical Institute, Jan Shikshan Sansthan etc.
- We have introduced a new service for children who cross 18 years of age – After Care support is provided in areas related to further studies, hostel, transport, apprentice, job opportunities etc.



Impact

- Child Care Plans – **700+** children
- Vocational trainings conducted – **700+** children trained
- After Care support – **5** children supported



Capacity Building of CCIs

- An audit of CCIs on the basis of the stipulations of the Juvenile Justice Act 2000 was done
- CCI management and staff were taken through workshops on the JJ Act with an aim to provide clarity on the various requirements stipulated in the Act
- With regards to various Staffing requirements of the JJ Act, we stepped in to provide Managers, case workers, caretakers, tuition teachers, cooks, cleaners etc.



Impact

- JJ Audit – **43** CCIs covered
- CCI staff trained – **35+** staff
- **25** staff provided – **1000+** children benefitted



Recreation & Fun Activities

- Various festive celebrations, fun events & activities, sports and cultural activities, outings, picnics etc. have been conducted at all CCIs. Children themselves have taken responsibility of various events via the children's committee and have done a splendid job of executing different recreational events

Impact

- Fun Activities & Festival celebrations – **2800+** children participated



CSA Fund Raising / Promotional Events with Corporate Partners



- **CSA's 10th Annual Fundraiser Charity Brunch 2014** was held on 2nd November 2014 and just like the previous ones it was a successful event! We had senior company executives and their spouses sweep us away with their dance moves, it's amazing what a little music and moonlight can do! We auctioned off magnificent works of art and our guests participated in both silent and live versions of the auction. Several corporates supported our cause by way of sponsorships. Parsi times gave us fantastic media coverage and helped get our message across.

From the dancers to our supportive guests, from the beauty of the Taj Lands' End hotel, to the heart-warming reason that we were all there; it was a magnificent night.

- **'Airtel Delhi Half Marathon'** - Employees of **ICICI Prudential Life Insurance Co. Ltd.** ran to support CSA last year too at the Delhi Half Marathon 2014 and contributed funds via the Corporate Challenge
- **'Mumbai Marathon Jan 2015'** – Our participation in the Dream Run as part of the Mumbai Marathon this January was a huge success. Besides CSA staff, we also had staff volunteers join us from **Accelya Kale Solutions Ltd, Givaudan (India) Pvt Ltd and ICICI Prudential Life Insurance Company Ltd.** In all, 23 participants enthusiastically supported CSA! We also had some of our longstanding supporters run the full and half marathon and raise funds for CSA



- **'Back to School'** campaign – Staff from **Anglo Eastern Ship Management** visited our boys at the Girija home in Mumbai in May, spent some quality time with them and gave children several school articles such as school bags, notebooks, geometry boxes and crayon sets as part of the campaign. The kids were very excited and happy to receive new school supplies



- Children enjoy spending time with volunteers & our boys from the Swami Vivekanand Balakashram in Thane, Mumbai had a delightful session with 10-11 volunteers from **Anglo Eastern Ship Management** in April. Children showed off their acting skills by enacting a few real life scenarios and some brought out social messages through their act. Volunteers then had a discussion with children regarding career opportunities in the shipping world and children listened with rapt attention. They gifted around 300 books to the children and all in all it was a fun evening!

- A **'Friendly Cricket Match'** was organized between Balmandir boys in Panvel, Mumbai and the employees of our corporate patron **Accelya Kale Solutions Ltd.** during summer vacations. These kids had never had the chance of playing cricket on a life size cricket ground complete with proper cricket gear and a defined pitch. It was an exhilarating experience for the children who finally won the finals and their joy knew no bounds as they lifted the winner's trophy!



- **ICICI Prudential Life Insurance Company Ltd.** staff conducted a 'donation drive' in May 2014 in Madhya Pradesh and several sets of clothes & 2 new cycles were donated to 40 girls from a CCI in MP

- **'Independence Day'** celebrations in Pune – Independence Day was celebrated with 400 kids from BVJSS. 11 employees from the corporate **Eagle Burgmann India Pvt. Ltd.** were present. Everybody enjoyed the cultural programme put up by children. Kids also received prizes. Employees also collected a contribution and showed their willingness to donate to essentials required in kind

- **'Joy of Giving'** celebrations – 'Joy of Giving' week is celebrated during the first week of October. In Pune, 8 employees from **Accelya Kale Solutions Ltd.** celebrated the spirit of 'Joy of Giving' with **100** girls from the Observation Home. They played 'Dandiya' with kids and danced with them. Kids were treated to Pizzas, Panipuri and Chocolates and were very happy to mingle with the employees. In a short while, girls chose their favorite 'Didi' (elder sister) and 'Dada' (elder brother). Employees then gifted them jewelry sets (necklace, earrings & bangles) and also helped the younger ones to put these on!



- Some staff from **Anglo Eastern Ship Management** visited 50 girls residing at the Observation Home – Bhiwandi as part of the **'Joy of Giving'** week celebrations. They played games with the girls and were able to witness the girls showcase their talents in the areas of dancing, acting and mimicry. They then distributed jewelry and snacks that the girls had put on their wish list. In return, the girls gifted each staff member with handmade key chains which the staff truly appreciated.
- As part of the **'Joy of Giving Week – Grant a Wish'** program, **ICICI Prudential Life Insurance Company Ltd.** staff donated generously to fulfill various wishes that children from our partner CCIs had expressed. They also visited a few children's homes in Madhya Pradesh and distributed items requested



- **'Christmas celebrations'** – Christmas parties were organised jointly with **Accelya Kale Solutions Ltd.** across Mumbai, Pune and Goa. Close to 80 children from all 3 locations spend some quality time with staff within the office premises and had a blast! Many children visited an office for the first time in their lives & were keen on learning about different job roles that was explained to them by employees. Employees had organized games for the children along with exciting gifts followed by scrumptious snacks. Kids were excited to see Santa Claus and were thrilled to receive gifts!



- Employees from **Tata Consultancy Services** spent time with children from a CCI in Thane, Mumbai. They participated in various games, had sing song sessions with the children and the evening culminated with MacDonald's burgers! Thereafter, TCS staff distributed storage trunks for children to store their personal belongings which the children were thrilled to receive!

Presenting some real life adoption stories!

'Every Little Thing She Does is Magic!'



This is baby Deepika's * story who was adopted by Vijay and Preeti* when she was 5 months old from Maharashtra in March 2015.

See this picture of happiness here, it is the success story of one of CSA's proudest achievements, the adoption of beautiful baby Deepika* by loving and adoring parents Vijay* and Preeti*. Everything went almost perfectly, just like 'magic'; the connection was instant, the love was easily forth-coming and the baby was cradled in their arms in less than 20 days. Certainly a happy ending, although, we'd like to take you back to beginning of March of 2015, at the start of this story and I ask you to imagine baby Deepika being erased from the picture. Why? Because like all good stories, there were hurdles along the way. Vijay and Preeti had tried to conceive naturally, however, there were complications along the way that persisted for years. With a strong desire in their heart for a child, they contemplated adoption, but didn't dare broach the subject with their family due to the questions that surrounded adoption.

Eventually, after witnessing the pair's battle to become parents, their mother proclaimed; "enough of these treatments and pain" and she encouraged them to adopt. Though given the green light, parenthood is never that easy, and it certainly shouldn't be taken that lightly, and Vijay felt the same, and was embroiled by concerns on whether or not the baby would "adjust to accept us as parents" and if he could do the child 'justice' as a parent. Although Vijay wanted to be a father so strongly, a part in his heart was hesitant; "my fear was more for her, because if I could not give the love that she deserves, then that would be unfair to her". Vijay was essentially scared that a bond would not develop. Vijay's anxieties and fears were shared by his father and father-in-law and to add fuel to the fire, the uncertainty surrounding adoption was also playing on Vijay's mind.

On the other hand, there was Preeti, who had nothing but confidence. In the lead up to starting the adoption application, the pair sought advice and support from colleagues and friends. Some had seen their persistent desire for a child, others had gone through adoption themselves and Vijay recalled some advice that had been given to them. "A friend said 'don't worry about it, the connection will happen', and I caught those words and it really helped me!" Amidst the uncertainty surrounding

adoption and his fears and anxieties, the determination to love and care for a child prevailed and they started the adoption process in early March, 2015. CSA linked them with an adoption agency (Child Care Institute) in rural Maharashtra, over 1000 kilometres from their home in Mumbai and within mere weeks, baby Deepika was in their arms.

When asking Vijay about his apprehension about adoption, he graciously gave an honest account, however, he always quickly followed by recounting the absolute love and joy that Deepika brought into their lives. In fact, the pair feel that baby Deepika's arrival in their lives is like fate; "there must be some relation in past life as it feels like she [Deepika] has been there forever". Whilst Preeti is bouncing her baby girl up-and-down in her arms, they recall taking Deepika back home from the orphanage: "we went to her place, which is on the outskirts of Maharashtra, and, we were sitting in their office waiting for her, and my mum was with me, and she said "baby, let's go home" and she [Deepika] smiled and we felt that she was waiting for us, and we can't forget that smile till today".

Talking to Vijay and Preeti, it is clear that there are many challenges facing all parents, especially those who adopt – "Adoptive parents need tremendous family support, at least in India, it is very, very important" said Vijay. Luckily for the pair, their family love and adore Deepika since the very first moment they laid eyes on her. Vijay has urged that this parting message be given to parents considering adoption: "Having your own child is always a blessing, but adoption, I would say, is nothing less than that, and from my personal experience, I would say that fear, anxieties, everything like that goes away on the very first day".

'Daughter by Law!'

Adarsh & Karuna Kochar adopted Nayraa who was 4 months old at that time.

I grew into an atheist, until the first night she fell asleep in my lap and as i admired her peaceful angelic face, my heart whispered a silent prayer.

Nayraa Adarsh Kochar, our daughter. Nayraa is a special baby, she wasn't conceived in my womb like most babies, she was conceived in my heart and no doctor had to pull or slit her out of that special warm place which was where she was born and where she shall forever stay.

Nayraa is an adopted child.

No, it's not what you're thinking. Adarsh (my husband) and I are perfectly normal and of sound physical and mental health. We have no complications and we are fully capable of having our biological babies. It wasn't laziness or the time constraint either. Adoption wasn't our last resort to start our family, it was infact our first choice. Some couples decide to go through pregnancy in order to bring a child into their lives, we chose to go through some legal formalities to welcome a child who was already in this world, into our life.

I still remember the first day when we arrived at the adoption centre we asked to wait while they brought us the baby. In those 9 odd minutes of wait I probably emotionally went through every stomach churn one experiences during pregnancy and labour. The nervousness and the excitement of finally having a dream come true was so strong, it took me all effort to keep calm and behave human. There is indeed no feeling like the anticipation of holding your child in your arms, whether born to you or not. That bundle of joy will always be a bundle of joy!

While my mind tried to collate all these different emotions I saw a nurse walk down with a bundle of shawl in her arms. There she was – my doll. She was dressed in a pink and white sweater with a matching cap and knitted booties. One could tell from the attire that this very outfit had dressed many kids for their special day too. I took a moment before I stepped forward and embraced her in my arms.

She was all but of 4 months. Tiny little bundle, tiny fingers and a small round face. Her eyes though were big and curious. They sparkled even in the dimly lit office and looked straight into my eyes to have a conversation of their own. I knew from the instant I saw her that her name must do justice to how beautifully expressive her eyes are and a day later we named her Nayraa – the girl with big eyes.

So here she was in my arms, staring back confused at this woman who couldn't stop crying out of sheer joy. After years of dreaming about holding my child, here she was all real and much more precious than my mind could ever phantom. A few seconds later as though she understood what I felt, she reached out her little palm from her shawl and held on to my finger with a tight assuring grip. In that one moment of touch I felt the bond of a hundred umbilical. Her beautiful pouted smile right between her 2 dimpled cheeks was the icing on the cake moment for me. I don't remember how long I stood there and stared at her right in the centre of the room, but I do know had I been an artist could replicate every detail of that moment by memory alone.

I was distracted only to witness the tears of the To Be Dad who was standing right beside me and awaiting his turn with his little angel. This was the impact of a girl who was just 4 months, weighed about 4 kilos and had no connection with us what so ever till that moment she saw us. In those few minutes we grew from just being a couple who were here to see her to being parents of this wonderful girl we will protect and love for the rest of our lives.

I am not a scientist, I don't understand the concept of genes, blood line or blood groups as deeply like most other people probably do. All I know is my child who wasn't born to me is 10 months today and she has wonderfully accepted and adopted us as her parents. She loves to laugh and play with us, she is comforted with our presence and misses us dearly if we aren't around her. She looks so much like us these days that when people find the similarity we feel super proud.

I haven't had the honour of carrying her in my womb for 9 months, but she can recognise my voice from miles away. I can't breast feed her but that doesn't stop her from clinging to my chest every time she's hungry. She didn't live close to my heart inside my body but today she falls asleep listening to the sound of my heart, to her my heart beat is the lullaby. I didn't go through labour pain but every time she cries I know exactly what she needs to feel better. She doesn't share our blood group but she still calls me Mama and her dad Papa, like she will for the rest of our lives.

I may not understand the importance of a family legacy but what I do know is that this day when she wakes up crying and frightened by a bad dream my cuddle comforts her. In a pitch dark room where she can't see my face, she senses my feel and knows it's me. A nice warm cuddle later one can slowly hear her crying become small sobs followed by a little silence when she rests her head on my chest and then a curtain raiser of giggles, smiles and laughter.

No blood group can stop us from being happy parents with a happy child! She fills our life with so much joy, laughter and love. She is the reason we wake up each day with the hope of waking up forever more to watch her grow and love her each day a little more!

We did not adopt Nayraa so we could give her a family, infact this child of God not born to us is the reason we are a family today!

Open your hearts and watch how a child can open your lives to everything wonderful!

Praveen & Divya Kumar adopted little Devika in Dec 2014. Here's their first-hand account on their inspiring adoption journey.

Devika's tiny fingers touching our faces every morning as we wake up is the most wonderful feeling we have ever come across in our lives. This would not have been possible without the support of CSA.

All our questions and worries about adoption were answered the moment we saw the baby when she was just four months old. We will never forget the moment we saw her first, she came to us with a heartfelt smile as if we had just returned home from work. Since then we are on cloud nine. Devika has been with us for a month now and keeps our lives blessed with her smiles and giggles.

Adoption for us has been a wonderful thing and Devika is the life-changing journey that has brought immense happiness to our family. We are really blessed to be parents of Devika and pray to God to continue giving us strength to bring her up with the right values in life.

Foster Parenting Case – First Foster case facilitated in Goa by CSA

We successfully facilitated the foster care placement of an 11 year old girl in Goa with a 55 year old woman whose husband passed away. This is the first case handled by CSA and also the first foster care case in the entire state of Goa.

11 year old Rekha* was an orphan child since she lost both her parents to HIV. However, she was HIV negative and lived in an orphanage since she was 3 years old. She yearned to have a family of her own. On the other hand, Anitha*, a 55 year old woman had lost her husband a few years back. As a couple, they too were yearning for a child and had approached several Adoption Agencies with the hope of adopting a child, however, they never succeeded. CSA became aware of Anitha's desire to adopt and after a few discussions with her, she was willing to take 11 year old Anitha under foster care. When Anitha met Rekha for the first time, there was an instant connection and this just seemed like divine intervention! CSA followed up with the Child Welfare Committee (CWC) in Goa to get the process moving and after a wait of 6 months, CWC finally gave the nod for Rekha to be given under foster care to Anitha. Both mother and daughter are extremely happy with these turn of events & since Rekha is a totally orphaned child, Anitha is now looking to adopt her daughter legally!

Our Change Catalysts – Our Volunteers

Ms. Chelsea Elizabeth volunteered with CSA in January 2015 for a period of 2 weeks. Chelsea originally from the US has been working in India with the organisation – A Family for Every Orphan. She is passionate about under privileged children and is keen on understanding the adoption scenario in India, with a view to helping prospective parents adopt children in India.

Here is Chelsea's first-hand account –

"I came to CSA with one hope. I simply wanted to understand the domestic adoption process in India and be able to communicate it to others. I've searched, asked, and dug in so many places, trying to figure out domestic adoption in India. I've only come up with contradictions, confusion and more questions. CSA in a sense was my last hope.

My expectations were blown out of the water by CSA's extensive knowledge and wisdom concerning the adoption process. I spent an all too short two weeks learning from CSA and then collaborating to document the adoption process in a way that would free others to understand the process with ease.

Not only did I learn a ton, I was surprised by the friendships I made at every turn. The people working at CSA have hearts of gold and truly are working hard to make children's lives better.

CSA has immense potential to radically alter opportunities for the orphans in all of India. They're already doing it – in four states. After working with them for two weeks though, I've seen the need for CSA's work to spread all throughout India. I've grown weary of NGOs and their quick fixes, short term vision and lack of follow through. CSA was a pleasant surprise. They have set sustainability as their standard, holistic care as their vision and are in for the long haul.

While adoption is my passion, it's not the only work that CSA does. CSA understands that many children in India will never be adopted – millions will call an institution their home. In order to bring hope and opportunity to these children, who otherwise would have little support, CSA partners with institutions to offer vocational training, health workshops and life skills to these kids, but they do this with concentrated effort. CSA comes alongside institutions to strengthen them by giving them training, resources and materials. CSA doesn't step in and do all the work themselves. They want to help improve infrastructure – again keeping sustainability as their standard.

Working with CSA has opened my eyes to the realities involved with orphan care. This is not a single faceted project. You can't just throw an education program at these kids. You can't drop off toothbrushes and call it a day. Think of your own family. Can you imagine if someone came in and taught your kids how to brush your teeth, then twice a year someone would come in and do a health checkup and then maybe (if you're lucky) a volunteer came to your home to drop of books and encouraged your kids to read?? When we think of it in a family context it seems preposterous. However, this is what we as a society think is good enough for these children. We want to do our part by donating our sum of money, our bags of rice or a stack of books. CSA knows better and is working to care for children holistically, and in a way that will give children a shot at having a future.

I would highly recommend volunteering with CSA if you're interested in true restoration and growth for the children of India who are in need. That being said – come knowing that CSA and these children have far more to offer you, than you'll ever have to offer."

2 boys from Pune Observation Home get selected for jobs via campus placements after completing 2- wheeler repairing course

Two out of ten under privileged children, who underwent training in a two wheeler repairing course have been able to successfully get themselves placed via campus interview. The training program was spread over a 45-day period held at PJNUK (Pandit Jawaharlal Nehru Udyog Kendra) premises by Kohinoor Technical Institute (KTI), Hadapsar, Pune, as boys are not allowed to go outside. The 2 boys placed via campus interview were under 18 when they did the course and had a few months to go. The 10 participants were part of PJNUK located in Yerwada-Pune, an observation and juvenile home for children. CSA thought it prudent that these boys be imparted with some skill development to give them confidence and career option, before they leave the juvenile home. We appreciate the support of District Women and Child development (DWCD) Pune, Juvenile Justice Board (JJB), Resource Cell for Juvenile Justice (RCJJ), Kohinoor Technical Institute (KTI) and Pandit Jawaharlal Nehru Udyog Kendra to ensure success of this activity. Ongoing vocational courses are being conducted with an aim to equip these boys with skill sets that will enable them to take up employment and get rehabilitated back into mainstream society.

Looking Ahead

There are huge gaps as far as child development and overall rehabilitation of children residing at CCIs goes. CCIs are barely able to provide basic needs – reasonable nutrition, accommodation facilities, hygiene and healthcare. Besides, education levels are poor, no individual child care plans, no career counselling, vocation training options are very few and no linkages to job opportunities in place. The net result is poor rehabilitation outcomes and children are left to fend for themselves once they complete 18 years.

Secondly, on the adoption front, the number of adoptions have remained stagnant over the years. However, the number of parents waiting to adopt are increasing, thereby, leading to a huge demand supply issue. More children need to be moved into the adoption stream so that they can be permanently rehabilitated with families.

The following areas will be focused on in the coming year –

(1) Building Model Child Care Institutions (CCIs) – The goal of this project is to provide children in orphanages/CCIs with good living conditions vide our 'Go Wide' programs and also look at optimal rehabilitation outcome for every child and build capacity of the CCI vide our 'Go Deep' programs.

While Government Schemes are in place that CCIs & children can benefit from, often lack of knowhow on the part of CCIs & loopholes in the process prevent CCIs from gaining access to funds in a timely manner. One of our objectives is to help CCI's understand the rationale & take necessary steps to access government schemes so that over time financial dependence on partners like us can reduce.

(2) Transfer of children without parental contact from CCIs to Adoption Agencies – During the course of our work with CCIs, we undertook an exercise to identify possible number of children residing at CCIs who could be potentially rehabilitated. We identified several children who didn't have any parental contact and after a social investigation of their background, it was established that majority of these children could be rehabilitated with families.

Therefore, we propose to put up proposals with the State governments of the states we work in to identify children who could be moved into the Adoption stream. We see a huge potential and will work towards making eligible children legally free for adoption which will give them a chance to get rehabilitated permanently.

The team at CSA is expanding and gearing up to take on additional responsibilities!


I. Significant Accounting Policies
