
















PRESIDENT'S FOREWORD

The primary theme last year was expansion of our work. From 60+ CCls, we have moved to 87 and today, we support nearly 4500+ children. We will cross 100 CCls in the coming year. We also built our Aftercare program and have more than 320+ Care Leavers in the program and along with Alumni; we work with more than 425+ Care Leavers. A big 'thank you' and congratulations to the entire CSA team for their hard work and these huge accomplishments!

This growth also makes us one of the largest NGO's working in the Child Protection space.



We also did a study of children that had been de-institutionalised and sent to live with their family. The study revealed that in a vast majority of cases, there was deterioration in their nutrition and education indicators. Most importantly adequate social investigation is not being done in many cases and no follow-up visits were done. The study highlights the need for proper 'gate keeping' at both entry and exit of the child and that deinstitutionalization is done mindfully keeping the best interest of the child as the core principle.

As I write this note, we are in the 5th month of the Pandemic crisis. It is not only a health issue but one which has an adverse impact on the economy, livelihoods, education, mental health and much more. Some of the indicators of distress due to COVID that we are already seeing are:

- » During 20th March till 10th April, Childline witnessed a 50% increase in calls to 460,000 calls resulting in 9,383 interventions. Rates of child marriage, emotional and sexual abuse, trafficking, abandonment, neglect and child labour are expected to increase, especially of girls, as seen in earlier disasters. (Source: UNICEF report)
- » CCIs are locked down with restrictions on entry of visitors and non-residential staff. Limited staff resources make running homes more challenging. Similarly support and monitoring is more difficult for government and NGO partners.
- » Children in CCIs are cooped up with no interaction with the external world. They are bored and scared. Mental health issues could increase for them.
- » Schooling is either shut or semi online (which is quite challenging to do without proper resources). Tutors are not able to visit in person. There is a huge loss of educational opportunity for these children.
- » 72% of CCIs reported that they fear lack of funding this year and may have to close down.
- » 40% of Care Leavers have not been paid a salary and 30% have lost their jobs. This is a huge and heart-breaking setback for these young adults and even day to day living can become a challenge.
- » Many skilling institutions have either suspended their courses or have moved partially online. 45% of Care Leavers are unable to continue with their courses.



» 61,804 children, out of 400,000 children living in Child Care Homes have been discharged. It is not known how safety and protection are being assured to these children in their homes. (Source: UNICEF report)

All of these indicators are pointing to one brutal truth – vulnerable children will be very badly impacted. There is likely to be a surge of children requiring institutional care and at the same time, CCIs are struggling. All of the issues that CSA is working on – Strengthening CCIs, Aftercare Services, Vulnerability Mapping, and Mindful De-institutionalisation are even more important in this time of crisis and beyond.

In response to some of these challenges, CSA has started a large Digital Engagement Program for our CCIs. The central idea here is to equip each CCI with a Computer Lab, a Smart TV and a decent internet connection. This digital infrastructure is then used to deliver educational and stress-busting content and engagement with the children. Remedial education / regular school classes as well as coaching is being done online. Zumba, yoga and art classes are being conducted by experts. Children in different institutions can say hello and interact with each other. Our Program Officers are able to talk to the trustees and the children over Zoom and WhatsApp calls. In many ways, the constraints of distance and location are being overcome and new opportunities for children are being opened up.

Similarly for our Care Leavers, we have decided that each of them will be given a smartphone and internet connection at the time they enrol in our program. They are being encouraged to join online courses and upgrade other skills as they wait for job opportunities or their training facilities to reopen. As an example, 100+ Care Leavers have been enrolled in an online English language program called Enguru and are learning an important skill for their jobs – conversational English.

In this crisis, I hope that all the stakeholders working in the field of care and protection think hard about how we can achieve excellence, scale and impact. In particular:

- » We must think about a PPP (Public-Private Partnership) model between NGOs and Government so that responsibilities of the state are discharged more effectively.
- » NGOs must collaborate between themselves so that duplication is avoided, best practices shared and scale achieved.
- » We must use technology and data analysis for planning, monitoring and measuring outcomes and impact.

Every crisis is also a time for change, an opportunity to reinvent and reimagine. I hope that we seize this moment and ensure that our children receive the "family like care" that they deserve.

I would like to end by thanking all our donors and supporters. It is due to your generosity that we are able to work. At this time, we need your support even more!

A NOTE FROM THE CEO

When I look back at 2019, I am filled with joy, gratitude, and pride in what we achieved for our children and what our children accomplished for themselves.

I am proud to share that we have expanded our reach to 87 Childcare Institutions and now serve 4500 children. We are the sole partners for some of these homes as they are located in the most remote and rural parts of the country. Every new home we partner with is a humble step towards our objective of serving more children under institutional care.

Speaking and thinking of the children we ultimately serve always brings me joy. This year is no exception. We are immensely proud and delighted to share that **93**% and **89**% of those who appeared cleared their 10th and 12th grade exams respectively



this year. To me, this reflects our children's innate desire to work hard, succeed and build something for themselves, which keeps us motivated and focused. One of our goals has been to strengthen the aftercare program. 425+ of our children were supported under our aftercare program this year. We are happy to share that 100+ of our young adults are employed, independent and leading a life of dignity.

Our children come under institutional care due to their difficult circumstances but that should not determine their path in life. We, at CSA, believe that working closely with our institutions and strengthening them through programs, training and other initiatives will equip them to provide the care of a family environment to every child. This does not only include avenues to good health, but also safety, companionship, and happiness. We are pleased to share that 86% of our children are within normal health and BMI standards. For those who do not meet these parameters, we offer supplementary nutrition, with the goal of eliminating nutrition-related issues in our homes. We also work with tuition teachers to provide individual support to every child through small group instruction, ensuring that our children are literate.

Turning 18 is a milestone for many, but this is not the case for our children. For those under institutional care, it is a dreadful and nerve-wracking moment because they have to exit the only home they have known, the place they have spent a significant number of years in, often without skills, education or a clear path to an independent life. We begin preparing our children to face the world at 18 by equipping them with life skills, digital literacy, financial literacy, an adolescent health program, and spoken English. In 2019, over 170 children were certified by NIIT, 300 children participated in the life skills program and 230 in our financial literacy program. We are excited to share our learnings from our work in the aftercare space in our recently published white paper "Empowering Youth Leaving Care at 18".

While we work for our children, who are under institutional care, we are constantly reminded of those who do not come under our purview or even under the purview of institutional care. A recent study estimates that there are **30 million** children who are vulnerable and require attention. With this objective, we conducted a large-scale vulnerability mapping exercise in Madhya Pradesh to train **8000** front line workers to identify vulnerable families and children and to bring them to the notice of authorities so that they can get the support required.

As we were closing the year, COVID-19 struck and generated a completely new and different set of challenges. We moved quickly to ensure that our homes are stocked with basic needs and hygiene products

and continue to monitor them for the months to come. We needed to transition to a digital learning environment to ensure that learning is never disrupted or stopped for our children. Our Aftercare children have had serious challenges as their courses have stopped mid-way and some have even lost their jobs. We are closely watching the situation and doing our best to support them. I want to thank each and every one of you who swiftly stepped forward to bolster and encourage us during this continuing crisis. Our work this year will largely be shaped by this situation and we would love to hear your ideas and suggestions for how to best protect our homes and children.

As we move towards what lies ahead, I am deeply grateful to all our supporters who have stood by our side all along as well as those who have recently come onboard. None of what we do is possible without your generosity and belief in our work. Thank you for the faith you have in us and in our children. I know they will make us all proud. We have a long way to go and thank you once again for joining and walking this path with us.

Sandip Soparrkar is a German trained Ballroom and Latin Dance expert. He has trained the likes of Britney Spears, Shakira, Beyonce and even the pop diva Madonna. In Bollywood, he counts superstars like Hrithik Roshan, Priyanka Chopra, Kajol and Ameesha Patel amongst those that he has trained. Sandip is the recipient of 3 National Excellence Awards, 1 National Achievement Award and the DadaSaheb Phalke Award.

Sandip shares his thoughts on being an Adoptive parent and the need to ensure more children are available for adoption -

"I adopted my son, Arjun in 2007 and soon, came to be known as the first single male Adoptive parent in India. It was the culmination of four



years of perseverance in the face of uncertainty. Arjun is almost 15, and is making me proud in more ways than one. He loves strumming his guitar, playing with the dog, going out with friends and swimming. Of course, now he does not want Papa around. He wants to do his own thing. In many ways, Arjun has taught me to be reflective, to question what I do, why I do it. I never did that earlier. To me parenting is about friendship - it's a lifetime bond that gets stronger each day.

My association with CSA as their Cause Ambassador dates back to November 2010. It's been a decade and a journey that I am proud of! One of the most heartening features that I see today is the transformational change in the mind-set of Indians. I remember, when I adopted Arjun, adoption was a rare novelty, attracting some curiosity and a great deal of bewilderment. Today, I can see that it has become a way of life; more and more Indians are adopting which is truly heartening.

However, the number of adoptions continues to dwindle and in a country with over 30 million children in need of care and protection, why are more children not moving into the adoption stream?

Adoption is by far the best outcome for a child - much better than institutional care. Some reasons for low adoption in India can be attributed to lack of awareness amongst civil society, social workers, police, NGO's and other stakeholders coupled with the Lengthy and cumbersome adoption processes.

CSA's field research and work with CCIs shows that there are many children without parental contact that are languishing in CCIs. CSA through continuous workshops and training focuses on bringing these children into the adoption stream and consistently works towards increasing awareness on Adoption.

I am proud to be associated with CSA and commend them for the phenomenal work they are doing in keeping vulnerable children safe and protected. "I encourage you to come forward and support CSA in their work!"

Livia was the first child in Goa who was placed with her foster mother Maria through CSA's efforts and her story was featured as part of a film shot by HBO. Heroes from Pune

Children from one of our Pune CCIs participated in **District level Kabaddi competition** organized by Women and Child Development Department Pune. They won the competition and qualified for the Divisional competition and stood first in the divisional level competition.

Akar Shisode from one of our Pune CCIs stood **second** in his college and scored 78% in his HSC - 12th grade examination.

Children from Girivanvasi Pragati Mandal CCI in Dahanu participated in **Bal Mahotsav Palghar District** competition and **Bal Mahotsav Konkan District** competitions and won 16 and 25 prizes respectively across various categories.





Children from Government Children's home participated in **sports festival** organised by **WCD department, Thane** and won 13 prizes in various sport events.



Rekha is from a CCI based on the outskirts of Mumbai. She was diagnosed with tuberculosis in March last year, and her haemoglobin level was very low; with proper medical care and nutritious diet, she has now recovered from tuberculosis. Despite her health condition, Chaitali was able to prepare for her SSC - 10th grade exams and has passed her examination with 66.5%.

Once children turn 18, they have to move out of the Child Care Institutes (CCIs) and have to figure a way to navigate through the complexities of life on their own. We are committed to supporting these young adults to enable them to be able to stand on their feet. Here are a few inspiring Young Adults who have beaten the odds and are progressing towards a promising future.

Graphic Designer with Clover Infotech, Mumbai



Jumman was just 3 when he lost his parents. With the help of a social worker, he was admitted into a CCI and after becoming 18, he was transferred to an Aftercare Home in Mumbai. He overcame all his struggles and completed his HSC with 72%. With CSA's intervention, he enrolled for a graphic design course and was able to get placed at one of our CSR Partner - Clover Infotech's office as a Graphic Designer trainee. Jumman was also the first young adult from our program to participate in the Tata Mumbai Marathon in January 2020 in the 10 Km category. He underwent training with Striders. and he successfully completed his race in 1hr 8mins! We are proud of Jumman and can't wait to see what life has in store for him!

AND PY MIC F. IGOI

Sales Executive with Zudio store, Thane-Mumbai

Vinita lost her parents when she was 10 and along with her brother was admitted to a CCI in Dahanu. Once she turned 18, she was shifted to Kshamata Foundation (Girls Aftercare Home) in Thane. Through our Flight @18 program, we were able to help clarify her career related doubts. We enrolled her for a Retail Management course at TATA Strive for 3 months. She completed the course and was placed in Zudio Store, a clothing brand as Sales Executive. She is earning ₹10,000 per month with incentives. Vinita is confident and armed with a smile, she is ready to take on the world!

Hardware Technician in Goa



Akash was born in a very poor family and with limited exposure, financial pressure and with support, he was unable to clear his Grade 10 examination. In order to support his family, Akash started doing some odd jobs like working at a petrol pump, other times as a delivery boy. With CSA's intervention, Akash was enrolled in a basic hardware networking course and was also motivated to reappear for his exams. Akash completed his basic hardware networking course in December 2019 and secured a job as a Hardware Technician in "Softech Computer Services" - Panjim, Goa with a salary of ₹8000 per month. Presently, he is continuing with his work and is preparing for his open school grade 10 exam via NIOS. We wish him the very best with his future!

Working at a hotel in Baramati



Sarika's parents are farmers and due to financial difficulties, she has been staying at a CCI in Pune. With the help of CSA's career awareness sessions, she was enrolled for a Hotel Management course in Baramati. After completing her 6 months course, she is now working in Hotel Sai Inn, Baramati and earning ₹9000 a month and financially supporting her family. Sarika is happy to be able to support her family and she looks forward to a bright future!

Sales Executive at HDFC Bank, Madhya Pradesh



Simran is a single parent child & her journey is very inspiring. She is an intelligent girl with a positive outlook towards life. She was enrolled by her maternal uncle in one of CSA supported CCI in Madhya Pradesh. After scoring 78% in Grade 12, she was in a dilemma as to what is in store for her. Seeing her inclination and seriousness, we enrolled her for an Office Administration Course from ICICI Academy of Skills and got her placed in HDFC bank as a Sales executive. Currently, Simran is pursuing her higher education and we are glad to be a part of her journey!

CREATING SUSTAINABLE CHANGE THROUGH ADVOCACY

Vulnerability Mapping and Adoption Awareness project

We partnered with the Department of Women and Child Development (DWCD), Indore Division, Madhya Pradesh for a pilot project to train 8000 Anganwadi Workers (AWWs) in 4 districts of the Division to conduct a vulnerability mapping exercise. The objective of the training was to enable the AWWs to identify vulnerable children in their area and report them to appropriate authorities for necessary action. 51 trainings were conducted to train almost 8000 AWWs from Indore, Khandwa, Dhar and Barwani. They were trained on child rights, provisions related to Children in Need of Care & Protection (CNCP) in the Juvenile Justice Act, 2015, and alternative care for CNCP.

The training was followed by a survey conducted by AWWs to identify CNCP in their local areas. Close to 2000 forms with the information of children in possible need of support were received by us. Around 400 investigations were conducted by us which needed urgent attention and the information was submitted to the district authorities.

Post-training, information was received by the CSA team from an Anganwadi worker about two destitute children living with their mentally challenged mother in the outskirts of Indore. A detailed investigation by the CSA team revealed that the children had no one to take care of them and had to beg to feed themselves. This investigation report was handed over to DWCD who then forwarded it to Childline for rescue of the children. While the children were rescued, produced before the Child Welfare Committee, and placed in a child care institution, the mother was admitted to a hospital by the police for her medical needs.







CSA's Aftercare program whitepaper - "Empowering Youth Leaving Care at 18" - released

We published a whitepaper describing our learnings from providing Aftercare services to over 300 Care Leavers together with our partner **A Future for Every Child**. Our Aftercare program prepares kids above 14 years of age growing up under institutional care for life outside the CCI. It also supports those who leave institutions on turning 18 for completing their education, to get vocational training, and to find a job so as to enable them to lead respectable and independent lives. This paper documents the processes employed, strategy, challenges, and learning which CSA has gained in the process of supporting 300+ Care Leavers since 2016. The objective of the paper is to highlight the various components of a successful Aftercare program which enables youth leaving institutional care to become contributing members of the society.

"Does deinstitutionalization always serve 'best interest' of the child?" - A study

We conducted a study to understand the ground realities of the restoration of institutionalized children with their families, and published a paper with our findings. The paper argues that deinstitutionalization without necessary precautions, adequate support, and monitoring of outcomes can actually be detrimental to the best interest of the child. The study analyzed the outcomes of restoration of 29 children who were in institutional care. Points of analysis included the legal and administrative process which was followed for restoration, whether post restoration monitoring and support was provided, and how restoration had impacted various growth and development parameters of the children. The study found that in most cases, the process mandated by law for restoration was not followed and post restoration support was provided to none of the children. In its conclusion, the paper recommends necessary action to protect the best interests of children who are restored to their families.

CAMPAIGNS

#SchoolChaleinHum - Back to School Campaign

"An investment in knowledge pays the best interest". Our goal with this year's Back to School campaign was to bring joy and cheer for our children as they began their new school year. The campaign was amply supported by in-kind donations and monetary support. We raised ₹50,000 through our online campaign. We were able to provide children with new stationary kits, school bags and books. With your help and support, we could make a child's future happy & bright!









#YouCanGiveToo - Daan Utsav Campaign

"For it is in giving that we receive" was this year's motto for Daan Utsav and all the activities revolved around giving the children from supported Child Care Institutions a different experience and engaging them in activities which made them socially more responsible, aware and gave them an opportunity to give back in their own ways. The CSA team in Mumbai spent one afternoon with young, vibrant, confident girls from an Aftercare home in Thane named Kshamata. We engaged in singing, dancing, diya painting & jewellery making all of which was led by the girls. The highlight was a display of beautiful hand-made items by the girls which got sold out in no time!

Through one of our corporates - ICICI Prudential Life Insurance, we were able to raise ₹57,000 for children from CCIs in Madhya Pradesh.

Adoption Campaign

Adoption carries the added dimension of connection and widening the scope of what constitutes love, ties, and family. We fully support legal adoption that can provide children from CCIs a loving home. According to the Ministry of Women and Child Development, about 8,677 children, including 5,033 girls* are available for adoption at childcare institutions. Opening your heart to children in need will not only fill that void and complete your family, but will also give these children the love that they deserve.

The month of November is celebrated as International Adoption Month. Our endeavour is to move more children into the adoption stream and we ran this campaign to garner support towards various adoption initiatives. Through this campaign, we raised ₹2,00,000 which was generously matched by a donor by ₹1,50,000. We are thankful to our donors for their support in making this campaign successful.





#SantaBankeDeko - Christmas Campaign

For most of us, Christmas is a time of joy, but there are children in child care institutions who do not experience a joyful and warm Christmas. We created a series of social media posters around this theme - Become 'Santa' for children at CCIs. With the help of a few of our donors, we were able to spread cheer and smiles during Christmas.





Tata Mumbai Marathon 2020 - Runner Campaigns

At the TMM2020 this year, for the very first time, one of our supported young adults, Jumman participated in the 10Km category run. Jumman, a teenager, grew up at a childcare institution for a major part of his life. He trained with Strider's team for a few weeks prior to race day. A fundraising page was set up and we were successful in raising close to ₹2,00,000. Jumman was also able to complete his run in 1 hour which is a huge feat for him as this was his first experience of participating in such a big event.
